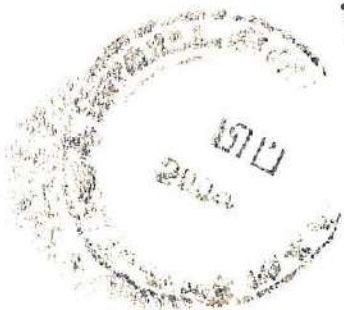

3. The first board of Trustees shall consist of the following persons namely,

4) The object of the Trust shall be

5. To maintain a center for training in 'Educare' (Education for Human Excellence) to organize seminars, conferences, meetings and workshops for the purpose of spreading value-based education and other related services.
6. To organize, arrange and convene educational activities, including study-circle, public lectures, seminar, conferences and to incur the necessary expenses thereof.

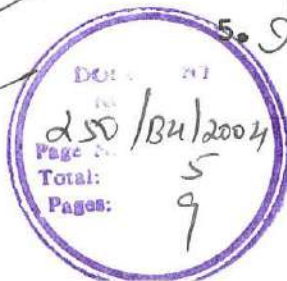

7. To undertake educational activities including programme oriented towards human values besides formal education combind with development of character of the students without any restrictions as to caste, creed, or religion or economic status.
8. To help and give relief to poor and deserving students in the matter of education without any restrictions as to caste, Community, creed or religion.
9. To provide free or subsidized boarding and lodging for poor and deserving students to enable them to pursue education without any restrictions as to caste, Community, creed or religion.
10. To promote literature, fine arts, music and sports among children, by providing various facilities such as training, motivation camps, etc.,
11. To open libraries, common reading rooms and such other places for dissemination and sharing of knowledge.
12. To conduct vocational training classes etc for the poor and needy.
13. To supervise or contribute or otherwise assist humanitarian, charitable, benevolent, public or any other useful institution/ Society having above mentioned objects and purposes.
14. To receive donations and assistance in cash or in kind for the furtherance of the above objects and in particular for the acquisition of immovable and movable properties of the Trust.

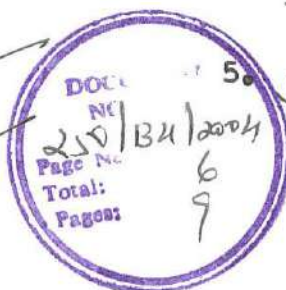

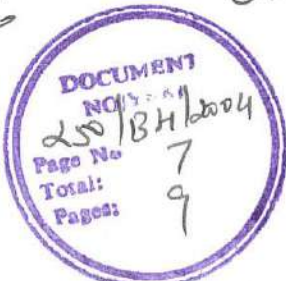

15. To merge with or to take in other trusts having similar objectives.
- 5) The Board of Trustees shall consist of five persons, Any vacancy arising in the Board due to the death, resignation or removal of any existing member shall be filled up by the remaining board of Trustees by the method of Co-option. Any person above the age of 35 years and who is devoted to the cause of education and devoted to the high ideals and principals of Bhagavan Sri Sathya Sai Baba may be Co-opted to be a member of the Board of Trustees.
- 6) All decisions of the board of Trustees shall be taken as far as possible by total consensus. If it is not possible, it may be by simple majority. All such decisions shall be binding of the Trust.
- 7) The financial year of the Trust shall be from 1-st April of the year of 31-st March of the succeeding calender year.
- 8) The Trustees have this day contributed a sum of Rs.1000/- (Rupees one Thousand only) on the whole towards the initial corpus fund of the Trust. AS on date there is no movable/immovable property in the Name of the Trust except the Corpus Fund of Rs.1000/-
- 9) The Trustees may accept donations and contributions from any persons for the furtherance of the objects for the trust.
- 10) The Trustees may open one or more bank accounts and nominate any two of three among themselves to operate the same jointly.


- 11) The Trust shall have its accounts audited by duly appointed qualified chartered accountant.
- 12) All the properties and income of the Trust shall vest only with the Trust and the Trustees shall be entitled to manage and administer them.
- 13) Any Trustee may resign from the Trusteeship after submitting a letter of resignation. Any trustee may be removed from the Trusteeship if he is considered to be acting in a manner prejudicial to the interest of the Trust. Such removal may be done by a resolution passed by a majority of the Trustees in the meeting.
- 14) The quorum for any meeting of the board of Trustees shall be three.
- 15) The board of Trustees shall have one among themselves selected as the Chairman, who shall hold office for three years.
- 16) No person who is an undercharged insolvent or convicted in any criminal case or of unsound mind shall be eligible to be appointed or continued as a Trustee.
- 17) The Trust shall have the Power to amend or modify any of the above mentioned clauses by common consensus of the Trustees so as to suit the arising needs from time to time in achieving its objectives.

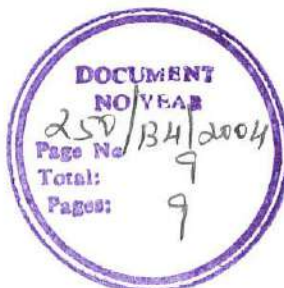

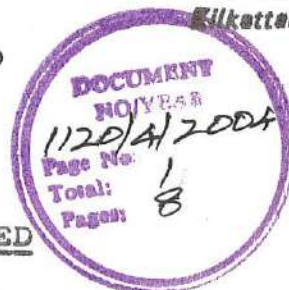
